From the I-81/I-70 Interchange: Take 70 West to the **Clear Spring Exit** (8.4 miles from the I-81/I-70 interchange); Go north on MD 68 (at traffic light the road jogs slightly to the left); Continue through the light. Follow the brown sign for Indian Springs Ski Area. Follow the veer to the right to Broadfording Road. Take the first left on Blair Valley Road. Go three miles; drive past several farms and houses; Pass the lake and barn on left. Turn left on gravel road into the trial grounds.
