Follow the brown sign for Indian Springs Ski Area. Follow the veer to the right to Broadfording Road. Take the first left on Blair Valley Road. Go three miles; drive past several farms and houses; Pass the lake and barn on the left. Turn left on gravel road into the trial grounds.
