Directions: From DC: Take 495 to exit #39 (River Rd., just north of Cabin John Bridge). Go west towards Potomac for approx. 11 miles to MD 112 (Seneca Rd). Turn left & continue on River Rd for approx 4 miles & turn left on Sycamore Landing Rd. Watch for Weim signs to grounds. **From points West:** Take Rt 15 to Rt 28 (just north of Pt of Rocks bridge). Take 28E for approx 21 miles to Darnestown. Take right on Rt 112 for 3 miles to River Rd. Continue on River Rd. to Sycamore Landing Rd.
