## **Armband Numbers / Check-In:**

Armbands will be available at the check-in table (alphabetical **by handler**). If your armbands are not in the check-in box, then we did not receive a copy of your dog's Jump Height Card. If you forgot to enclose your height card, or have had your dog recently measured, just present your height card or yellow temporary height card at the Secretary's table to receive your armband labels **prior to running**.

**Check-in for measuring:** Friday: Begins at 9:15 a.m. Saturday & Sunday: Begins at 7:15 a.m. Additional measuring time will be provided (as available) as courses are being set. If a measurement is necessary, it is the exhibitor's responsibility to have their dog(s) measured prior to running. We will have a **Volunteer Measuring Official** (Blair Kelly) at the trial. **Reminder:** All exhibitors should carry their dog's original AKC official Jump Height Card with them to each trial, in order to present the card, should they be asked, upon request.

**Move ups** for the July 18 trial must be received by 6 p.m. on Monday, July 14. Move-ups for Friday-Saturday or Saturday-Sunday will be allowed and must be submitted in person to the trial secretary within ½ hour of the end of judging each day.

**Paved parking** is located close to the building. No **RV's or ex-pens** will be allowed in the parking area. No **overnight parking** at the show site. Please do not block the driveway. Additional parking is now available at the new office building on the left of the driveway.

**\*\*There have been reports this spring of theft from vehicles while they are being loaded/unloaded.\*\*  
*Do not leave your unlocked vehicle unattended.***

**Crating/setup:** The building will **NOT** be available for set-up on Thursday evening. Set-up will start on Friday at 8:30 a.m. There is plenty of crating space available. The entire lower building will be available on Friday. **Waterproof cloth or tarps must be placed underneath crates.**

**Food and refreshments** will be available at the trial site.

**We wish to thank all those who have volunteered to help at this trial.** The worker coordinator will be Suzanne Honeyman (e-mail: [vxweims@comcast.net](mailto:vxweims@comcast.net)) Any and all assistance makes for a smoother running trial, so please check with her often to see how you can help! The volunteer schedule will be sent via e-mail and/or posted to the club's web site (<http://www.dcweimclub.org>) on/about July 14.

**Remember! Keep the area clean!** As always, exhibitors are responsible for cleaning up any deposits left by their dog. Any exhibitor failing to pick up after their dog will be EXCUSED without benefit of refund if the Show Committee deems the exhibitor is in violation of this requirement. While the use of **flexi-leads** is not prohibited on show grounds, we urge you to use them responsibly. Failure to properly control a dog at an event can be grounds for a misconduct hearing. Let's keep this site dog friendly! ☺

## **Directions to Carroll Indoor Sports Center:**

From **Baltimore:** From Baltimore Beltway (I-695) take Exit 19, Northwest Expressway (I-795) towards Owings Mills/Reisterstown. Continue until the Expressway ends, bear right onto Route 140 West. Follow 140 West for approx. 10 miles, turn left onto Route 97 (Weis Market on right, PetSmart market on the left.) At the 2<sup>nd</sup> light, turn Left onto Old Westminster Pike. The Carroll Indoor Sports Center will be on the right a short distance after the turn.

From **DC & Virginia:** From DC Beltway (I-495) take I-270 exit towards Frederick. From 270, take Damascus exit (Route 27 North). Stay on 27 North approx. 25 miles to Main Street in Westminster. Turn right onto Main Street. Go 1.5 miles. C.I.S.C. will be on right side of road after crossing over Route 97.
