Directions: From *Virginia*: Outer Loop of the Beltway (495) to Pennsylvania Ave (Rt 4). East on Pa. Ave to Rt 301. South on 301 for approx 7 miles & take a left onto Cherry Tree Crossing Rd (yellow caution light). Make sure you stay on Cherry Tree Crossing Rd when it makes a right turn about a 1/4 mile later. Then take a left at the first dirt road (watch for Weim sign). Take dirt road for 400 yd. to parking area. From *Baltimore:* South on 95 to Washington DC Beltway. Take Inner Loop to 301 South. Follow the above directions.
